The International Baccalaureate<sup>®</sup> (IB) is currently seeking an experienced individual to take on the role of **Deputy Examiner Responsible for its Norwegian Literature** course.

The International Baccalaureate<sup>®</sup> (IB) is a non-profit educational foundation offering challenging programmes for a worldwide community of schools. It is now represented in over 145 countries and in over 4,600 schools. The IB provides an international pre-university curriculum and an international university entry qualification, which gives access to higher education on a worldwide basis. One of the characteristics of the IB's Diploma Programme is that students are required to study, as one of six subjects that constitute the diploma, one of three 'Language A' courses, each designed to develop high social, aesthetic and cultural literacy, as well as communication skills. The IB's **Language A: literature** course is for students aged 16-18, and involves the study of both literature originally written in the language of the course, and works of other languages and cultures studied in translation. Emphasis of the course is directed towards developing an understanding of the techniques involved in literary criticism and promoting the ability to form independent literary judgments.
